April 03, 1995

On April 03, 1995 the Middlesex Governing Body met in regular session with members Mayor Harvey Lewis, Commissioners Bascoe Lewis, Isaac Lewis and Naomi Powell present, Commissioners Jerry Daniel and David Jordan were absent. Mayor Lewis called the meeting to order at 7:30 p.m. and Commissioner Powell gave the invocation.

The Minutes and the Financial Statements for the previous meeting were presented and accepted as correct in a motion by Commissioner Powell, seconded by Commissioner Bascoe Lewis and carried unanimously.

Utility Supervisor, Sanford Wilson was present but did not have any item of business to bring before the board.

Chief Brock was present to give a report on the police activities for the previous month. There was a discussion on speeding inside the city limits, and Brock stated that it was a problem but some businessmen complained that too many tickets would keep people from coming into town. He stated that the town was in need of a valid parking ordinance.

Alvin Brantley was present and requested that the town look into the possibility of having a traffic light installed at the intersection of South Nash Street and Hanes Avenue.

There was a discussion on the installation of the carpet by Bailey Furniture. The clerk stated that Mr. Liles had the Vice-President of Intertex and also the salesman that sold him the carpet to come by and look at it. They both stated that the carpet was not of second grade quality, but it was a random pattern showing up at different places. The clerk stated that Mr. Liles had sent his installers back to try to correct the problem of the seams, and there had been some improvements but they were still very visible. She also stated that she had contacted the painter, John Smith and he said it would cost \$300.00 to repair the base board that the carpet installers had damaged when putting down the carpet.

Commissioner Isaac Lewis moved to deduct the \$300.00 from the Bailey Furniture's bill and to send him the balance, and he could accept it or take up the carpet and we would begin anew to get carpet, his motion was seconded by Commissioner Bascoe Lewis and carried unanimously.

There was a discussion of stray dogs, and Chief Brock said he had spoken to the new family on Mill Street in reference to their dogs.

The board reviewed the contract for the sewer line to Zebulon and asked the clerk to schedule a meeting for the town attorney and engineer to meet with the board.

The board reviewed dates for the League Regional Meetings. Mayor Lewis stated that he would be attending the one in Roanoke Rapids.

The board reviewed a letter from Nash Social Services wanting the town to participate in the Nash Job Internship Program. The clerk was instructed to meet with them to discuss the program.

Commissioner Powell moved to adjust the water bill for Middlesex Methodist Church from \$111.90 to \$64.90, her motion was seconded by Commissioner Isaac Lewis and carried unanimously.

Being no further business, Commissioner Bascoe Lewis moved to adjourn.
