

December 04,1995

The Middlesex Governing Body met in regular session on December 4,1995 in the town hall. Members present were Mayor Bobby Bissette, Commissioners David Jordan, Bascoe Lewis and Isaac Lewis, Commissioners Jerry Daniel and Naomi Powell were absent. Mayor Bissette called the meeting to order at 7:30 p.m. and the invocation was given by Commissioner Isaac Lewis.

The Minutes of the previous Minutes were accepted as being recorded correctly in a motion by Commissioner Isaac Lewis, seconded by Commissioner Bascoe Lewis and carried unanimously.

The clerk presented the Financial Statements for the months of October and November, Commissioner Jordan moved to accept them as correct, his motion was seconded by Commissioner Isaac Lewis and carried unanimously.

Chief Brock was present to give a report on the activities of the police department for the previous month.

Commissioner Jordan stated that he had met with Mike Acquesta, Town Engineer and told him to proceed with the design for the sewer line for RockSide to tap into the manhole for sewer discharge. Jordan stated that the State will not issue a permit without an engineered design.

After reviewing a written request from Bascoe Lewis, Commissioner Jordan moved to adjust Lewis's water bill from \$139.40 to \$79.00, his motion was seconded by Commissioner Isaac Lewis and carried.

Mayor Bissette discussed the curbing and guttering project on NC231 Highway, and questioned if we should try to get the sewer into the ground prior to the state doing the curbing and guttering. Mayor Bissette decided that he would get in touch with Len Ward of the Department of Transportation to discuss the issue before the next town meeting.




At the November meeting a motion was made to purchase a boring tool for approximately \$4,000.00 if the Town of Bailey wanted to share the expense and tool. The clerk stated that she called the clerk in Bailey to see if it had been approved and was told that Bailey approved to pay 1/2 the cost but were told that they could use Middlesex's air compressor without charge when they needed it. Clerk Bissette asked if that was this board's wishes. She also informed the board that \$1600.00 was deducted from Kenneth Raper's bill for the water project on NC231 because the cost of the taps were figured into his labor, so in essence, \$1600.00 had already been paid on the machine.

Commissioner Isaac Lewis made a motion to inform the Bailey Governing Body that the Town of Middlesex would not be furnishing an air compressor free of charge to be used with the boring tool, Lewis's motion was seconded by Commissioner Bascoe Lewis and carried unanimously.

Mayor Bissette stated that he inspected the floor of the building rented to Rhonda's Flea Market and that it was in bad need of repair. Commissioner Bascoe Lewis moved to repair the floor and bring the building up to compare with the one next door to it, his motion was seconded by Commissioner Isaac Lewis and carried unanimously.

Commissioner Jordan moved to re-imburse Luther H. Lewis, Jr. and Derek Bissette for the expense of the water line on the east side of Buck Deans (formerly Children's Home) Road minus the cost of the taps involved, his motion was seconded by Commissioner Bascoe Lewis and carried unanimously.

Being no further business, Commissioner Bascoe Lewis moved to adjourn.
