The Middlesex Governing Body held a Special Meeting in the Conference Room of the Town Hall for a workshop to review the proposed 2005-2006 Budget. Mayor Pro Tem Harold Meacombs called the meeting to order at 7:30 p.m. Members present were Commissioners Luke Robinson, Derek Bissette, and Basco Lewis. Commissioner Fred Hough was absent.

Town Administrator Peggy Bissette began by first reviewing the current pay for each job position, the recommended pay class code, and the recommended salary for each position for 2005-2006. Bissette's proposed class codes and salaries were based on the MAPS Group study completed in March 2003, which Susan Ennis and Bissette had adjusted down 5% from the original study.

Bissette reviewed current water, sewer, and sanitation rates and all fees charged by the town and recommended no changes.

Expenditures and Revenues were reviewed by department and by line item. Board members were in agreement that Bissette had presented a good budget. Bissette answered questions concerning salaries and there was some discussion.
