Lambert also advised that Anthony & Tabb, PA, the town's auditor, had completed the on-site audit of the 2014-2015 records, and they would be coming soon to deliver the audit report to the Town Board.

Mayor Lewis mentioned that all the grease awareness education by the town and the Girl Scouts is working and the grease problem is getting better.

A new house is being built by Ike Bullard on Rockside Road in Village Square Subdivision, a new modular has been placed in Southwinds Subdivision, and three more houses are to be started in Cedar Run Subdivision, so the growth continues to look very good.

Resolution R2015-1148 was presented for adoption to close a portion of S. Nash Street (Hwy 231) and West Hanes Avenue for the Christmas Parade on December 12, 2015 from 2:00 – 3:00 p.m. The Christmas~N~Middlesex Program will be held from 11:00am to 4:00pm. Police Chief Murray, with assistance from others will handle traffic and the Fire Department, and be present to help. Business owners will be notified and permission has been received from NC DOT. Commissioner Lewis moved to approve Resolution R2015-1148 for street closures for the Christmas Parade. Commissioner Davis seconded, and the motion passed unanimously.
